

Subsequently, they can join the legal profession as Advocates, Solicitors, or Judges.

For those who decide to pursue careers outside the legal field, this internationally recognised law degree paves the way for opportunities in a myriad of global industries. It is a highly respected qualification in both the government and corporate sectors. This degree is especially sought after in industries such as banking, media, property, business, politics, non-profit organisations (NGOs), and many others. It is also invaluable for those aiming to be social advocates. Public listed companies and most large firms typically have an in-house legal department, where possessing a law degree would make you an indispensable member of the team.



The Certificate in Legal Practice (CLP) is a prerequisite qualifying examination for admission to the Malaysian Bar. If you have obtained the minimum requirements in your LL.B results, you may proceed to read for the CLP course. The exams are conducted by the Legal Profession Qualifying Board, and it is regulated by the Legal Profession Act 1976.

Here, you will delve into practical applications across various subjects, ensuring you are well-prepared to tackle exam questions effectively. You will develop a well-balanced perspective of academic law and practical applications. It is essential training to develop the necessary skills required as a lawyer. 


